# NOAHIDE LAW

## NOAHIDE LAW - LAYMANS DEFINITION

Over the last decade there has been a rise in messianic Judaism as efforts by evangelicals to spread the gospel to Jews has resulted in a significant rise in Jews becoming born again believers. This is a fantastic development as Jews come to the realization the messiah will come again to establish his physical kingdom on earth.



This fascinating trend has raised a number of theological debates concerning this dispensation of grace and how it applies to Jews.

However whilst we have been looking into this area a few years ago we also came across something known as the “Noahide Laws”. This is something that maybe foreign to you but a little research showed that it is a term which is known in the Christian community. Below is a description from the website gotquestions.org.

The Noahide laws are seven ancient laws that many people view as the basis of civilized society. They govern morality and represent the “bare minimum” of what God expects of humanity. They are called the “Noahide” laws because they are thought to have been given in their fullness to Noah after the flood. They are also called the *Noachian laws*, *the Seven Laws of Noah*, or *the Seven Commands for Noah’s Sons* (in Hebrew, *Sheva Mitzvot B’nei Noah*).

The idea of a formal set of laws given to all humanity (all the sons of Noah) comes from the Talmud and is therefore extra-biblical. Some scholars believe the *Book of Jubilees* contains a possible mention of the Noahide laws. But, again, the *Book of Jubilees* is not inspired Scripture. However, the Noahide laws are based in biblical principles.

Here are the Noahide laws:

1. Do not deny God (no idolatry).
2. Do not murder.

3. Do not steal.
4. Do not engage in sexual immorality.
5. Do not blaspheme.
6. Do not eat of a live animal (no eating flesh taken from an animal while it is still alive).
7. Establish courts and legal systems to ensure obedience of these laws.

According to Jewish tradition, the first six of these seven laws were given to Adam in the Garden of Eden (the sixth law, to not eat live animals, was extraneous, since Adam did not eat any animals). When God established His covenant with Noah, He added the seventh (and the sixth became applicable). Each of the seven Noahide laws is seen as a summary of more detailed laws, about 211 total.

According to Judaism, a Gentile does not have to follow the Mosaic Law; however, all Gentiles are obliged to follow the Noahide laws. The laws given to Noah’s children are universally binding. A non-Jew who abides by the Noahide laws is considered a “righteous Gentile,” according to Judaism, and will earn a reward in the afterlife, if his obedience is coupled with a knowledge that the laws come from God. A “righteous Gentile” might also be called a “Hasidic Gentile” or simply a “Noahide.”

Nowhere does the Bible record what laws God may have given Adam, other than the command to fill and subdue the earth and the prohibition against eating of the tree of knowledge of good and evil (Genesis 1:28; 2:17). After Noah and his family exited the ark, God gave the following three commands to him: “*Be fruitful and increase in number and fill the earth*” (Genesis 9:1); “*You must not eat meat that has its lifeblood still in it*” (verse 4); and “*Whoever sheds human blood, / by humans shall their blood be shed; / for in the image of God / has God made mankind*” (verse 6). After that, God repeats His command to “*be fruitful and increase in number; multiply on the earth and increase upon it*” (verse 7). Other than Noah being told not to eat raw meat, there is no hint of the traditional Noahide laws in these passages.

### The Seven Noahide Laws

1. **BELIEF IN G-D**  
Do Not Worship Idols
2. **RESPECT G-D AND PRAISE HIM**  
Do Not Blaspheme His Name
3. **RESPECT HUMAN LIFE**  
Do Not Murder
4. **RESPECT THE FAMILY**  
Do Not Commit Immoral Sexual Acts
5. **RESPECT FOR OTHERS' RIGHTS AND PROPERTY**  
Do Not Steal
6. **CREATION OF A JUDICIAL SYSTEM**  
Pursue Justice
7. **RESPECT ALL CREATURES**  
Do Not Eat the Flesh of an Animal that is Still Alive

The only other place in Scripture where a Noahide law might be mentioned is Acts 15:29. The context of this passage is the Jerusalem Council, which met to address the issue of the Gentiles’ place in the early church. Specifically, the question before the council was, “*Must Gentiles be circumcised according to Mosaic Law in order to be saved?*” (see Acts 15:1).

# NOAHIDE LAW

The apostles in Jerusalem answered with a resounding "no." We are not saved by keeping the Law (see Galatians 2:16). However, to promote peace within the early church, the council advised Gentile believers to avoid four things, including the eating of "blood" (verse 29). None of the other three instructions correspond to any of the Noahide laws.

As an ancient moral code, the Noahide laws have been a major influence in many cultures. In fact, in 1991, both houses of Congress passed a bill, signed into law by President George H. W. Bush, that declared the Noahide laws to be "*the bedrock of society from the dawn of civilization*" and the "*ethical values and principles . . . upon which our great Nation was founded*" (H.J.RES.104.ENR).



Are the Noahide laws found in the Bible? No, not as a definitive list, and they are certainly not associated with either Noah or Adam. Are the Noahide laws congruent with biblical teaching? Yes, although it is important to note that we are not saved by rule-keeping; God requires faith in His Son (John 3:18).

## THE DARK SIDE OF NOAHIDE

The description above of Noahide Law doesn't seem to indicate anything wrong except for the danger of it being enforced in a way that could become legalistic. This would be in contrast to the words of the Apostle Paul who was clearly against legalism in his day.

As mentioned above in December 27, 1991, President Bush signed into law a Congressional Joint Resolution entitled, "*A Joint Resolution To Designate March 26, 1991, As Education Day, USA*". This joint resolution became Public Law 102-14. The title seems so innocuous that no one would think twice about it if they happened to just see it.

*Public Law 102-14* states emphatically that all civilization from the beginning has been based upon a set of laws entitled "*The Seven Noahide Laws*". These seven supposed universal laws,

according to the *Encyclopedia Americana*, p. 737, state that they are

"A Jewish Talmudic designation for seven biblical laws given to Adam and to Noah before the revelation to Moses on Mt. Sinai and consequently, binding upon all mankind."

"Throughout the ages, scholars have viewed the Noahide Laws as a link between Judaism and Christianity, as universal norms of ethical conduct, as a basic concept of international law, or as a guarantee of fundamental human rights for all."

This explanation leaves one to believe that both Jews and Gentiles are bound by these seven laws; however Jewish sources state that the Jew who lives according to the Torah is exempt from these seven laws. In other words, these seven Noahide Laws were meant for the Gentiles only!! They are meant to be a substitute for the Ten Commandments.

The penalty for violating any of these Noahide Laws is spelled out on page 1192 of the *Encyclopedia Judaica*,

"... violation of any one of the seven laws subjects the Noahide to capital punishment by decapitation."

In other words, if one person steps forward to accuse a Gentile of violating any one of these seven laws, that testimony alone would be enough to decapitate the accused. A person could be put to death for the flimsy accusation of being cruel to animals, and based on the lying testimony of one person!!

Notice, there is no assumption of innocence until proven guilty, nor of the prosecution having to prove their case. No, on the accusation of one person, the accused may be legally decapitated.

The *Encyclopedia of Judaism* locates the Noahide Laws in the Talmud Bavli, the Babylonian Talmud. It is important to realize that there are two editions of the Talmud, the Jerusalem Talmud and the Babylonian Talmud.

Of these two, the Babylonian Talmud is authoritative for Orthodox Judaism, which regards it as divinely inspired. The superiority of the Babylonian Talmud is so great, that when people now talk about the Talmud, .

Scholars will claim that the Talmud is partly a collection of oral traditions given by Moses which had not yet been written down in Jesus' time. However, Christ condemned the traditions of the Mishnah (early Talmud) and the Scribes and Pharisees who taught it, because the Talmud nullifies the teachings of Scripture. In Mark 7:1-13) Jesus' warning against the traditions of men that make null and void the Word of God is a direct reference to the Mishnah.

Moreover, the commands found in Genesis 9 and Acts 15 are not the equivalent of the 7 Noahide Laws of the Kabbalist/Lubavitchers, nor does the context in which these commands appear have any relation whatsoever to the radical agenda of the movement promoting the Noahide Laws.

The Jewish Encyclopedia elaborates:

"In the elaboration of these seven Noachian laws, and in assigning punishments for their transgression, the Rabbis are sometimes more lenient and sometimes more rigorous with Noachidæ than with Israelites. With but a few exceptions, the punishment meted out to a Noachid for the transgression of any of the seven laws is decapitation, the least painful of the four modes of execution of criminals (see Capital Punishment).

The many formalities of procedure essential when the accused is an Israelite need not be observed in the case of the Noachid. The latter may be convicted on the testimony of one witness, even on that of relatives, but not on that of a woman. He need have had no warning ("hatra'ah") from the witnesses; and a single judge may pass sentence on him (ib. 57a, b; "Yad," l.c. ix. 14). With regard to idolatry, he can be found guilty only if he worshiped an idol in the regular form in which that particular deity is usually worshiped; while in the case of blasphemy he may be found guilty, even when he has blasphemed with one of the attributes of God's name—an action which, if committed by an Israelite, would not be regarded as criminal."

## THE LUBAVITCHERS

On the University of Calgary web site, the pages of Professor of Religious Studies, Dr. Eliezer Segal, present much information about ancient and modern Judaism. One of the modern schools of Judaic philosophy is Chabad-Lubavitch Hasidism, which Dr. Segal describes as a Kabbalist movement:

"The name 'Chabad' is a Hebrew acronym for the expression 'Chokmah,' 'Binah' and 'Da'at' — Wisdom, Intelligence and Knowledge. These Kabbalistic terms are

central to the distinctive intellectual theology of the movement... The name Lubavitch refers to a town in

Lithuania that was the centre of the movement for a brief period during the nineteenth century... Chabad Hasidism continued to be a major force among Russian and Lithuanian Jews from its inception...

"In 1940 the head of the movement Rabbi Joseph Isaac Schneerson moved to America from Russia. From the outset he expressed his determination to make the Lubavitch movement into an American religious movement (e.g., by abandoning the traditional European long frocks in favour of American-style dress)."



This group is the ultra-orthodox Lubavitch Movement, known for its strict adherence to the smallest detail of the Talmud. Until his death in 1994 this group believed their head Rabbi, at the time, Menachem Schneerson, was the prophesied Messiah,

Here is a quote from Rabbi Louis Finkelstein, the head of *the Jewish Theological Seminary of America* in 1943, writing in the *Universal Jewish Encyclopedia*,

"Pharisaism became Talmudism...the spirit of the ancient Pharisee survives unaltered. When the Jew studies the Talmud, he is actually repeating arguments used in the Palestinian academies."

In other words, the Talmudic Lubavitchers are reborn Pharisees. This should be concerning because many Pharisees belonged to the Jewish occult group, the Cabal. We have previously studied that the Jewish Cabal forms a most important foundational building block upon which the entire New World Order movement is based.

We are thus aware of why these Pharisees could hate Jesus Christ so vehemently, even in the face of His tremendous miracles. We understood how Jesus possessed such hatred of the teachings and the hypocrisy of the Pharisees.

The doctrines of the Lubavitch Movement are derived from the *Kabbalah*, the source book of Jewish mysticism or Gnosticism. The *Encyclopedia of Religion* states that the Lubavitch Hasidic interpretation of the Lurianic system of Kabbalah is among those taught in traditional Jewish institutions:

"The dominant brand of Qabbalah in the modern Qabbalistic Yeshivot (traditional Jewish academies) is the Lurianic system. It is studied according to the interpretations offered by Mosheh Hayyim Luzzatto, by Eliyyahu ben Shelomoh Aalman, by Habad, the Lubavitch Hasidic Movement and by the Sefardic Qabbalists of the Beit El Academy in Jerusalem." *Encyclopedia of Religion*, "Qabbalah"

The "Lurianic system" of Kabbalah was developed by Rabbi Luria (Ari). Rabbi Luria is identified by the *Encyclopedia of Religion* as the most influential of the Kabbalist/Theosophists:

"The success of Luria's thought was instantaneous: his theosophy was accepted unanimously . . . and his Qabbalah was regarded as superior to the Cordoverian system." *Encyclopedia of Religion*, "Qabbalah"

This probably explains the reason why the Pharisees who witnessed many supernatural miracles of Jesus believed that He was able to accomplish the miracles because He was an Adept in the Egyptian Mysteries.

He could, therefore, supposedly access the power of the occult. Jesus warned them not to ascribe His power to Satan, but they continued to do so, thus committing the Unpardonable Sin. To this day, secret societies continue to teach their members that Jesus could do His many miracles because He was an Adept in the occult.

H.P. Blavatsky traces the Kabbalah to the ancient mysteries of Babylon and Egypt: *"As is well known, the Kabala never originated with the Jews, who got their ideas from the Chaldeans and the Egyptians."*

Blavatsky stated in her Theosophical Glossary:

"The kabalist is a student of 'secret science',... This secret doctrine is identical with that of the Chaldeans, and includes at the same time much of the Persian wisdom, or 'magic'... [T]he Kabala is derived directly from the primeval Secret Doctrine of the East; through the Vedas, the Upanishads, Orpheus and Thales, Pythagoras and the Egyptians. Whatever its source, its substratum is at any rate identical with that of all the other systems from the Book of the Dead down to the later Gnostics."

*The Secret Book of the Egyptian Gnostics* by Jeanne Doresse claims that the sacred Book of the Cave of Treasures is alleged to contain the secret teachings that were written by Adam who, prior to his interment in Persia, transmitted them to Noah.

According to the Gnostic tradition, "nascent Christianity" commingled with Zoroastrianism and the commands of Adam to Noah were preserved in Persia for the generations to come:

"The principle work in which ...all these traditions became synchrotized was The Book of the Cave of Treasures...It puts all these revelations into the mouth of Adam as the first of a long series of prophets, who predicts how the Magi will await the announcement of the Saviour, near this cave in which Adam himself will have been interred, and where the Treasures are concealed which the Magi will carry to Bethlehem..."


"In The Book of the Cave of Treasures ...let us quote from it these lines, supposedly spoken by the Magi: Adam imparted revelations to his son Seth...he recommended his son Seth never to fail in justice as he Adam had done. Seth welcomed the teaching of his father with a pure heart and it was given to him to inscribe this wisdom in a book and to teach it...And thanks to him, for the first time in this world, there was seen a book written in the name of the Most High. Seth bequeathed to his descendents the book thus written, and that book was handed down even to Noah... (who) took with him into the Ark the books of these teachings... He ordained in his turn that the generation that came after him were to repeat...the mysteries in the books of Seth...These mysteries and this narrative were handed down even to our fathers...who passed them on to us."

Under the guise of Torah Judaism, the Kabbalists are taking both Jew and Gentile back to Egypt, the ancient house of bondage - a fact confirmed by Theosophist, H.P. Blavatsky, who traced the Kabbalah to the mystery religions of Babylon and Egypt:

"As is well known, the Kabala never originated with the Jews, who got their ideas from the Chaldeans and the Egyptians."

# NOAHIDE LAW

## THE CONNECTION WITH FREEMASONRY



In *The History of Freemasonry*, High Adept and Prince of Masonry, Albert Mackey, provides the sequel to the Egyptian/Kabbalist accounts of Noah:

"After Noah's emergence from the Ark, he is said to have promulgated seven precepts for the government of the new

race of men of whom he was to be the progenitor... [1] To do justice [2] Worship God [3] Abstain from idolatry [4] Preserve chastity [5] Do not commit murder [6] Do not steal [7] Do not eat blood."

Mackey further identifies Noah as the originator of a mystery religion known as the Arkite Worship.

"The influence of Noah on Masonic doctrine is to be traced to the almost universal belief of men in the events of the deluge, and a consequent establishment in many nations of a system of religion known to ethnologists as the 'Arkite Worship... Hence arose that system known to modern scholars as the 'Arkite Worship' in whose rites and mysteries, which were eventually communicated to the other ancient religions. There were always some allusions to the events of the Noahic flood — to the Ark, as the WOMB OF NATURE, to the eight persons saved in it, as the Ogdoad or sacred number — and to the renovation of the world, as symbolizing the passage from death to immortal life."

It is from this Kabbalistic interpretation of Scripture that Freemasonry derived its initiation rite of the third degree, in which the Master Mason is baptized into the death of Osiris and resurrected to immortality.

Prince Adept, Albert Mackey, wrote that Masons are required by the Old Charges to obey the precepts of Noah as "the Moral Law," i.e., "that religion in which all men agree."

"...(A) revision of the Old Charges...contained this passage: 'A Mason is obliged by his tenure to obey the Moral Law.' In the edition of 1738, Dr. Anderson has, without authority, completed the sentence by adding the words, 'As a true Noachida. ...the only religious laws which a Freemason is required to obey are those which are contained in the code that has been attributed to Noah. This sentiment is still further expressed toward the close of the 'Old Charges' where it is said that the Mason is obliged only 'to that religion in which all men agree,' excluding therefore

atheism and requiring the observance of such simple laws of morality as are enjoined in the precepts of Noah."

Ahavat Israel explains that the children of Noah are the Gentiles:

"With respect G-d's commandments, all of humanity is divided into two general classifications - the Children of Israel and the Children of Noah. The Children of Israel are the Jews, the descendants of the Patriarch Jacob. They are commanded to fulfill the 613 commandments of the Torah. The Children of Noah are the Gentiles, comprising the seventy nations of the world. They are commanded concerning the Seven Universal Laws, also known as the Seven Laws of the Children of Noah or the Seven Noahide Laws."

According to Masonic doctrine, a Noahide is an average Gentile, while a "true Noachida" would be a "righteous Gentile" (eg., a Mason) who pursues the study and keeping of the 7 Laws, thereby attaining to an advanced level of spirituality:

"When one of the Children of Noah engages in the study of the Seven Universal Laws, he is able to attain a spiritual level higher than the High Priest of the Jews, who alone has the sanctity to enter the Holy of Holies in the Temple in Jerusalem."

Albert Mackey upholds the binding nature of the Noahide Laws for salvation and requires every Jew to enforce them:

"These seven obligations...are held binding on all men, inasmuch as all are descendants of Noah, and the Rabbins maintain that he who observes them, though he not be an Israelite, has a share in the future life, and it is the duty of every Jew to enforce their due observance wherever he has the power to do so."

The Jewish Encyclopedia states,

"The Noachidæ are required to establish courts of justice in every city and province; and these courts are to judge the people with regard to the six laws and to warn them against the transgression of any of them (ib.; "Yad," l.c. ix. 14, x. 11)

In conclusion it's a confused evil story but hopefully we have given you some insight into the concept of Noahide Law and why we shouldn't be deceived into thinking that its association with Noah and Judaism means that it's a good thing.

The one world government agenda is a twisted script impacting all religions including Judaism and Christianity. We all need to stay vigilant.
